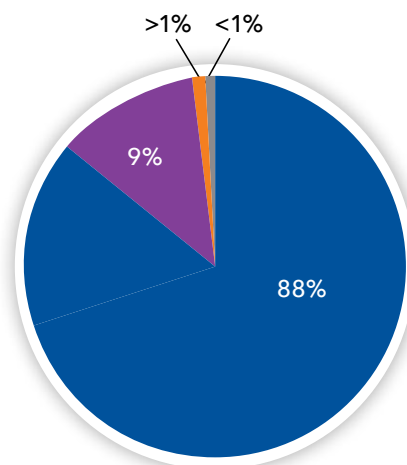

Adapting and Persevering

GRMC Continues the Battle against COVID-19

In 2021, COVID-19 continued to impact the daily operations at GRMC. Throughout the year, our front-line staff and hospital leadership worked together to ensure seamless care for our patients and all those who turned to GRMC for vaccinations, care and treatments.

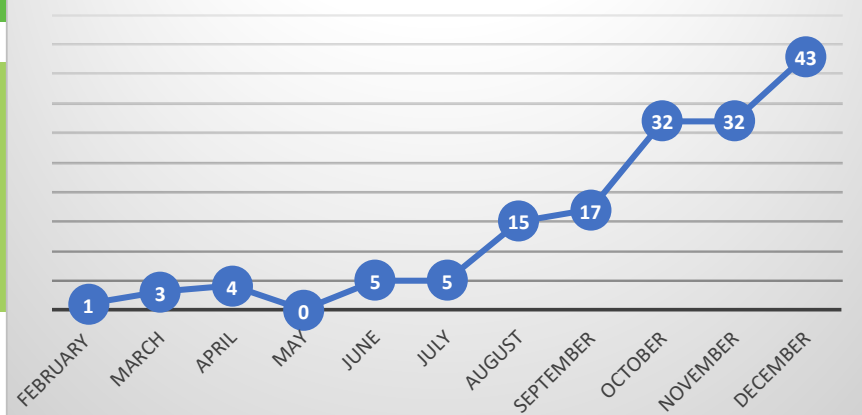
This past year, as we battled new surges of the COVID-19 virus, UnityPoint Health was ready and stocked with enough personal protective equipment to keep our team members safe. In response to the supply chain challenges of 2020, UnityPoint Health created its first permanent, systemwide, pandemic inventory. Strong collaboration between our supply chain, clinicians, analytics and others allowed us to meet this challenge.

UnityPoint Health - Grinnell Public Health administered 13,256 doses of COVID-19 vaccinations in 2021. "The COVID-19 battle has been one of constant change and the ability to pivot in a moment's notice. Our public health team has done an amazing job of doing just that, adapting and persevering through it all," says Shauna Callaway, director of public health.

GRMC continues to do all it can to prevent the spread of COVID-19 and to keep our patients and team members safe. Requiring masks at all GRMC facilities, restricting visitors, as well as promoting proper hand hygiene and mandating vaccines for all staff are many of the ways GRMC is doing all it can to bring our communities safely through this pandemic.

Another way GRMC is leading the way through the pandemic is by providing monoclonal antibody therapy for COVID-19 patients. Monoclonal antibodies, or MABs, are made in a laboratory to fight a particular infection and are given directly to the patient through an infusion. This therapy became available at GRMC in February 2021. Since August, when the Food and Drug Administration, Centers for Disease Control and Prevention and Iowa Department of Public Health (IDPH) began to encourage patients to get this therapy, the numbers of patients receiving MAB treatment has drastically increased, as indicated in the graph below.

Number of Patients Received MAB



"Some early evidence suggests that MAB treatment can reduce the amount of the virus that causes COVID-19 in a person's system. Research is showing that COVID-19 positive patients may have milder symptoms thereby decreasing the likelihood of needing to stay in the hospital. Qualification for this promising form of treatment depends on a patient's age, health history, and how long they've had symptoms of COVID-19," says Laura Juel, RN, MSN, NEA-BC, vice president of nursing and clinical services.

As GRMC continued to weather the storm of the omicron COVID-19 variant, the support of the community was invaluable to the morale of all team members. Our thanks to Grinnell College and Grinnell Mutual who collaborated to provide a holiday meal from Pagliai's for GRMC's team of healthcare heroes.

Mammography Accreditation at GRMC

GRMC was awarded a three-year term of accreditation in mammography as the result of a review by the American College of Radiology (ACR). The ACR gold seal of accreditation represents the highest level of image quality and patient safety.

"The ACR accreditation assures our patients that GRMC will provide quality diagnostic testing while adhering to the highest imaging standards," says Matt Byrd, TR(N)(CT), CNMT, radiology department manager. "Trust and confidence in our imaging equipment and our technologists' abilities will help us best serve our community."



GRMC Receives Birthing Simulator

The IDPH, in collaboration with the University of Iowa Department of Obstetrics and Gynecology, purchased a MamaNatalie Birthing Simulator for every level 1 hospital in the state of Iowa, which includes GRMC. Team members use MamaNatalie to train for situations such as normal delivery, postpartum complications and neonatal resuscitation to improve management of skills and communication from ambulance to delivery room.

GRMC Welcomes Two Clinics

In the summer of 2021, GRMC welcomed Surgical Associates of Grinnell and Montezuma Medical Clinic to the GRMC family.

Surgical Associates of Grinnell was established in 1968 as a private partnership of surgical specialists. Their surgical expertise currently features general surgeons and urologists, with minimally invasive and robotic surgery as well as renowned bariatric (weight loss) surgery expertise and experience.

Together, GRMC and Surgical Associates built Grinnell Bariatrics, earning a designation of a bariatric comprehensive center – one of only a few rural hospitals to hold the designation. Grinnell Bariatrics also holds the highly respected Blue Distinction designation from the Blue Cross Blue Shield Association.

Montezuma Medical Clinic was established as a primary care clinic providing personalized, family medicine care for patients of all ages. They are an independent organization, founded by Dr. Bernhard Wiltfang and led by Dr. J.B. Paulson, and have been affiliated with GRMC for several decades. Trusted providers with years of family medicine experience have given compassionate, patient-centered care for generations of patients and families.

"We are fortunate to have close and well-established relationships with both Surgical Associates and Montezuma Medical Clinic," says Jennifer Havens, chief executive officer at GRMC. "Formally adding them to our UnityPoint Health – Grinnell team will result in more efficient, coordinated health care services, including a shared electronic medical record, for our communities and surrounding areas."

Delivering the Future

Growing GRMC's Obstetrics and Gynecology Service Line

Pregnant women living in rural America face unprecedented barriers to maternity care today. More than 100 rural hospitals throughout the country have closed since 2010. Of those remaining 20% are at risk and many are choosing to shut down their obstetric (OB) units due to a growing shortage of physicians, nurses and anesthesia staff. In Iowa there were 79 hospitals with OB units in 2013; today there are only 56, a decrease of nearly 30%.

Hospital and/or OB unit closures mean rural women in labor face longer journeys, which lead to an increase in births outside of the hospital, births in hospitals without OB care, or births in an emergency department. These situations put the mother and the baby at risk.

GRMC is currently the only hospital with an OB unit in Poweshiek, Marshall, Tama and Iowa counties. For 60 years, a hospital has existed at Fourth and Reed

to provide an array of services from birth to end-of-life, striving to provide the *best outcome for every patient, every time*. We are committed to sustaining and growing this service line for future generations.

The first step to fulfilling this commitment is to actively recruit providers to staff our OB unit 24 hours a day/seven days a week. By the end of 2022, we will have four Family Practice/Obstetricians, two Obstetrician/Gynecologists, one Obstetrician, and one Midwife. With more providers, more space was required to serve their patients, so we relocated and enlarged the UnityPoint Health - Grinnell Obstetrics and Gynecology Clinic (OB/GYN Clinic). Opened in March of 2022, the new Clinic is co-located with Grinnell Family Practice Clinic on the third floor of the Ahrens Medical Arts Building and expanded from two exam rooms to five with a treatment room and space for consultations.

Continuing to respond to the need for important obstetric services within our region, GRMC's next step is to expand its OB unit in the hospital. Last renovated in 2000 with the support of John and Jewel Kintzinger, there are currently three labor and delivery rooms. However, more and more, those rooms are consistently full, and with the addition of new providers more rooms are needed. In 2021, more than 200 babies were born at GRMC, and the trend is expected to continue to rise.

Each time a baby is born at GRMC, we are reminded of our mission: *to improve the health of the people and communities we serve*. Our commitment to stabilize and grow our maternal health service line for the women in our region remains steadfast because we believe it is fundamental to our mission.

The Poweshiek County Alliance (PCA) Endowment Fund, in partnership with the Greater Poweshiek Community Foundation (GPCF), continued its legacy of impactful support to Poweshiek County with a grant to the GRMC Foundation for the purchase of three new transport chairs for GRMC. These chairs increase safe handling of patients and reduce staff injuries. Our new transport chairs offer many benefits for the patients and team members, including non-fabric, seamless design for easy cleaning and sanitation and raised, extended armrests for better patient access and transfer to chair or bed.

James Kaup, GRMC Emergency Department manager, praises the chair for its excellent braking system using a foot brake located on the back of the chair. He says, "This is superior to any other chair I have seen, making it much safer."

"We are very grateful for the continued support from the Poweshiek County Alliance Endowment Fund and the Greater Poweshiek Community Foundation," says Jennifer Havens, chief executive officer at GRMC. "These new transport chairs increase safety for our patients, their caregivers and our team members."

In addition to monitoring fetal activities such as heart rate, this device also has enhanced maternal monitoring capabilities including temperature, oxygen saturation, ECG and non-invasive blood pressure. Equipment purchases such as this are made possible because of philanthropic support.

In a time when rural Iowa OB departments are closing, GRMC's OB Department is expanding, thanks in part to generous donors like Larry and Echo Jansen, residents of Grinnell for more than 40 years.

"There are two things a community needs for survival and success," Larry says. "It needs a strong school system and a strong hospital. We want Grinnell to be an attractive place for young people to grow their families."

This belief led Larry and Echo to pledge \$50,000 toward the expansion of GRMC's OB Department.

"If we see something that we think is important and have the ability to assist, that's what we try to do," says Larry.

Echo's excitement shines when she talks about becoming a first-time grandmother later this summer. This new role created a spark that also encouraged the Jansens to want to give back to local maternity services.

"Having maternity services available locally not only serves parents-to-be, but also extended family members, business owners and the communities at large in the GRMC service area," says Echo, who spent 16 very fulfilling years as the activity director of GRMC's Adult Day Care Center.

The Jansens celebrated their 50th wedding anniversary in 2021, have a history of giving back to the Grinnell community and are actively involved in their respective churches and many community groups. Larry currently sits as vice chair of GRMC Foundation Board of Directors. A retired president of Grinnell Mutual, he was instrumental in their Board of Directors' decision to donate a transformational gift several years ago which brought the da Vinci Robotic Surgical System to GRMC.

"Larry and Echo's generous 2021 pledge toward the expansion of GRMC's OB Department shows an admirable and inspiring level of commitment to the community and the hospital," says Donna Fischer, GRMC Foundation's Director of Development. Donor Bill of Rights

Philanthropy is based on voluntary action for the common good. It is a tradition of giving and sharing that is primary to the quality of life. To assure that philanthropy merits the respect and trust of the general public, and that donors and prospective donors can have full confidence in the not-for-profit organizations and causes they are asked to support, we declare that all donors have these rights:

1. To be informed of the organization's mission, of the way the organization intends to use donated resources, and of its capacity to use donations effectively for intended purposes.
2. To be informed of the identity of those serving on the organization's governing board, and to expect the board to exercise prudent judgment in its stewardship responsibilities.
3. To have access to the organization's most recent financial statements.
4. To be assured that their gifts will be used for the purposes for which they were given.
5. To receive appropriate acknowledgment and recognition.
6. To be assured that information about their donations is handled with respect and with confidentiality to the extent provided by law.
7. To expect that all relationships with individuals representing organizations of interest to the donor will be professional in nature.
8. To be informed whether those seeking donations are volunteers, employees of the organization, or hired solicitors.
9. To have the opportunity for their names to be deleted from mailing lists that an organization may intend to share.
10. To feel free to ask questions when making a donation and to receive prompt, truthful, and forthright answers.
