My first thought in this new year is how grateful I am for you, the faithful supporters of UnityPoint Health - Grinnell Regional Medical Center (GRMC). Your gifts to the GRMC Foundation have really made an impact at GRMC. This includes...

- The purchase of new equipment and technology
- Specialized training for members of our team
- Enhancement of programs and services
- Provision of aid to patients who need a helping hand.

All this happened in 2023 because of you. *Believe what you do makes a difference because it does.*

In the year ahead, GRMC is looking forward to beginning phase one of the renovation and expansion of the obstetrics (OB) unit. Phase one includes building a new a recovery/observation room that will expand the unit's footprint in the hospital and then, following the completion of that room, the creation of the fourth labor, delivery, recovery and postpartum (LDRP) room. My thanks to all the donors who are making this possible! This is philanthropy in action!

I'm excited to share that GRMC has secured a **Community Facilities Block Grant** totaling **\$600,000** for the OB project. Adding this \$600,000 to the **more than \$800,000** in **monies awarded plus cash and pledges** raised through the GRMC Foundation to date puts us past the half-way point toward our project goal. We will, of course, continue our efforts to raise the remaining funds necessary to complete the entire project.

I'm also grateful for the members of the GRMC Foundation Board of Directors. I specifically thank outgoing board member and chair **Debby Pohlson**, who completed her fourth term at the end of 2023 for a total of 12 years of service. Debby was an outstanding board member and she will be missed. Stepping into the board chair position as of January 1, 2024, is **Dawn Disney-Bruggeman**. Dawn resides in Montezuma and is an Office Deputy for the Poweshiek County Sheriff's Office. She has been a board member since 2020, and I am looking forward to her leadership.



Elizabeth Tigges, DO, was interviewed on KCCI-TV on November 27th regarding maternal health for Native American women following the publication of a recent study in *The Journal of the American Medical Association* showing a significant increase in the maternal death rate for indigenous women in lowa.



Abby Flannagan, DO, was interviewed by *Business Record* for an article published on November 21st titled, "New Report Highlights Continued Maternal Health Care Concerns in Iowa." This article followed the release of the March of Dimes 2023 Report Card which highlighted a fourth straight increase in the preterm birth rate in Iowa and continued disparities by race/ethnicity across poor birthing outcomes.



Additionally, during the week of December 4th, Dr. Flannagan joined Blank Children's Hospital and Iowa Methodist Medical Center's maternity team members in hosting a Maternal Health Legislative Roundtable in Des Moines. The Roundtable was an opportunity for UnityPoint Health team members to educate Iowa Legislators and Executive Branch staff on the importance of maternal health in the state of Iowa. Dr. Flannagan spoke about the need to find rural workforce solutions to continue providing the best service possible to our communities.
