Connection to Allen

Ginny is a member of the 1962 class from the Allen School of Nursing, and the couple has generously supported every campaign at Allen College and Allen Hospital for decades.

Employment History

After graduating from Allen, Ginny began her nursing career in Iowa City while Mike was attending graduate school. Following that, the couple moved to Milwaukee where Mike worked for PricewaterhouseCoopers. He eventually transitioned to a successful career with a wholesale distributor of HVAC equipment and supplies. Mike retired in 2000 after serving as president of that company for 28 years.

Ginny worked in a general practitioner's office in Milwaukee before taking a pause to start their family. Later, she volunteered in grade schools as a nurse and did exams for insurance companies and other organizations.

Why have you chosen to give so generously to your alma maters?

Ginny's education with Allen School of Nursing provided her the ability to become a nurse and make a difference in many people's lives, Mike's education at the University of Northern Iowa (UNI) gave a strong foundation for him to have a successful business career which they are most grateful for.

Mike and Ginny have endowed scholarships both at Allen College for nursing and at UNI with an emphasis

in accounting. They say it is hard to describe the emotion they feel upon receiving a thank you note from their scholarship recipients. One grateful recipient recently said that because of their scholarship support, the student would graduate debt free. The McBride's know the high rate of debt that college students possess and feel it is instrumental to support scholarships so that students are set up for success in life. Mike and Ginny share a special relationship with their scholarship recipients and invite them for a visit to their home in Milwaukee during the summer.

Why are you inspired to give philanthropically?

The McBride's shared their philosophy regarding philanthropy:

- To whom much has been given, much is expected.
- It is not important how much you have, but what you do with what you have.
- The best use of one's life is to invest in something that will outlast life.

Mike and Ginny use these guiding factors throughout their philanthropic giving. The couple feels very blessed and have felt called upon to help others. They are inspired to give to organizations that make a difference in the lives of others.

In addition to their generous scholarship support, they have also invested heavily in brick-and-mortar projects at Allen, UNI, and to local organizations in the Milwaukee area. One of their most recent endeavors was supporting Kathy's House which is a hospital guest house for adults (similar to the Ronald McDonald House model).

Mike and Ginny knew Dr. Gerard quite well through their involvement with Allen over the years. When the Gerard Circle Society was created in his honor, the McBride's were compelled to support at this level.

IMPACT REPORT

The Allen Legacy Program kicked off in November of 2020 with a goal to recruit and retain Allen College Bachelor of Science in Nursing (BSN) graduates. The program provides financial assistance to students enrolled in the Allen College Bachelor of Science in Nursing (BSN) program and guaranteed employment at Allen Hospital. Upon graduation, successful completion of licensure exams and a three-year commitment to work at Allen Hospital in an area of need, nursing students can receive up to \$17,500 applied towards tuition the final two semesters of their Allen College education.

The endowment was initially funded in part by a donation from the estate of Keith and Dorothea Baskins. We are grateful to all of our donors who have helped make this program possible! Thank you for your commitment to Allen College and Allen Hospital. Your gifts are making it possible to retain high-quality healthcare providers at Allen Hospital for our community for years to come.

Lobeck Estate Gifts Nearly \$1 Million TO ALLEN FOUNDATION

UnityPoint Health – Allen Foundation received a nearly \$1 million gift from the estate of Laura Mae and Henry "Bud" Lobeck. The donation was made to benefit the new Legacy Program at Allen Hospital, as well as surgical services.

The funds are being put to good use. Half of the funds went to an endowment of the Allen Legacy Program, an incentive program to encourage Allen College graduates to stay local and pursue a health care career at Allen Hospital. In addition, funds were used to fully purchase a transesophageal echocardiography (TEE) machine and help to purchase a da Vinci robotic surgery system. Both items are vital assets to the surgery department at Allen Hospital.

"Henry and Laura wanted people to know what had become important to them, which was family, their health, the wellbeing of others and their church," said guarantors of the estate, Mary Kettwig and Jerry Lobeck. "We chose these designations in order to continue providing quality nurses to our community for years to come and to enable Allen Hospital to provide the highest quality of surgical care."

After a lifetime of living, working and service in Northeast Iowa, Henry passed away in 2019, followed by Laura's passing in 2020. In recognition of the generous gift that totaled \$990,467.50, the Allen Foundation has named the surgery conference room in honor of Laura and Henry.

Expanding Access to Care

THROUGH A SUCCESSFUL GIVING TUESDAY

On November 30, 2021, the Allen Foundation took part in the global day of giving. Giving Tuesday is a time when people around the world are encouraged to do good – and we were able to accomplish just that for patients in the Cedar Valley through this one-day event.

Allen Foundation partnered with local skilled nursing facilities such as Bartels Retirement Community, multiple Care Initiatives facilities, NewAldaya Lifescapes and Western Home to raise funds for innovative new equipment that creates continuity of care for patients as they transition out of the hospital.

The TytoPro 24/7 Medical Exam Telehealth System helps providers remotely assess lung sounds, measure heart rate and temperature. The device can also visualize skin and wounds, while investigating ears, nose and throat when assessing a patient's general condition. The ability to provide this type of assessment on-site leads to more timely treatment and could potentially prevent a trip to urgent care or the emergency department.

Thanks to many, we are excited to announce that more than \$23,000 was donated on Giving Tuesday in support of the TytoPro telehealth project!

Giving Tuesday also included two exciting opportunities to have gifts doubled. Over the noon hour, all gifts made up to \$1,750 total were matched by UnityPoint Health's IMPACT Team of providers. Then, from 5 to 6 p.m., all gifts made totaling up to \$2,000 were matched in honor of Dr. Russell Adams and Dr. Daniel Glascock!

In 2022, the telehealth units will be placed around our community at skilled nursing facilities to assist the Allen Hospital IMPACT team of providers in offering accessible around-the-clock care. We thank everyone who contributed to this important project, which furthers our mission of providing the best outcome for every patient, every time!

Behavioral Health Services Continues to See Increased Need

After more than two years of the COVID-19 pandemic, the demand for mental health services is surging. Mental health providers throughout our community, the state and the country are experiencing an unprecedented increase in the demand for these services. At the same time, the profession is experiencing its worst shortage of professionals in years.

Prior to the pandemic, progress was in motion to improve access to and availability of mental health services. Access to these services has been identified as a top need from multiple community health needs assessment surveys, and now those challenges are magnified.

Despite these challenges, we're proud of the accomplishments we made during the pandemic:

- Expanded access to services via virtual platforms like Doximity, Vidyo, Teams, Zoom, AmWell and others.
- Opened Mental Health Walk-In Clinic at Allen Hospital.
- Cedar Valley Nonprofit Awards, hosted by the Nonprofit Leadership Alliance at UNI, recognized Black Hawk-Grundy Mental Health Center as Exceptional Nonprofit of the Year.
- Fully staffed Allen Hospital's inpatient mental health unit without need and expense of locums tenens.
- Partnered with Columbus High School to provide student health coach to address and improve student/family involvement in addressing mental health.
- Black Hawk-Grundy Mental Health Center recognized as Partner of the Year through Grow Cedar Valley.
- Improved communication and coordination between not only UnityPoint Health providers, departments and affiliates but community partners who also address behavioral health.

- Continued efforts to educate community on suicide prevention through the Cedar Valley Coalition on Suicide Prevention and Support.
- Supported UnityPoint Health team members as they dealt with the impact of the pandemic on their work, personal life and family.
- Held 2nd Annual Mental Health Awareness Breakfast virtually with more than 300 individuals in attendance and raised more than \$30,000 for mental health services.
- Black Hawk-Grundy Mental Health Center awarded \$1.7 million grant from Substance Abuse Mental Health Services Administration to expand mental health services.

We harbor hopes of getting to a (new) normal and know the demand for mental health services will continue long into the future. Our commitment to meeting these needs with the dedicated professionals who work in this field will continue, as well.

In 2021, the Black Hawk-Grundy Mental Health Center continued its mission of meeting the mental health needs of our community in new and unique ways. Given the Center's commitment to educating our community, we chose to hold the 2nd Annual Mental Health Awareness Breakfast virtually versus in-person due to an increase in the COVID-19 positivity rate.

Despite the barriers created by the ongoing pandemic, over 300 individuals attended the event virtually. Attendees heard from dynamic speakers, Mary Neubauer and Larry Loss who spoke about a future of hope for preventing suicide after losing their 17-year-old adopted son Sergei, to suicide in 2017.

As we continue to increase awareness about mental health and the importance of treatment in our community, watch for future events hosted by the Mental Health Center.



Mental Health Walk-in Clinic Opens at Allen Hospital

Just like any other patient with an illness or injury, patients seeking help with their mental health might find that they need urgent help while not requiring a visit to the emergency department.

The Mental Health Walk-In Clinic, which opened in fall 2021, works much like an urgent care clinic, allowing people to get help when they need it. The clinic is housed at Allen Hospital and is open Monday through Friday from 9 a.m. to 4:30 p.m.

Because this clinic is a new service of UnityPoint Health - Waterloo, general financial support is being sought. Gifts help with start-up expenses and unexpected costs, and they ensure this new clinic is sustainable for years to come.

Making a Difference

The COVID-19 pandemic threatened to make 2021 just as challenging as the preceding year. However, we're pleased to say it was actually quite different. After all, we've learned how to navigate a lot of the unknown and found ourselves in a better position to provide the best of local health care. We came a long way in 2021, and we did it together.

Because you care, we continue to see countless examples of progress toward a healthy and well community. We're encouraged by the continued financial support and engagement of nearly 1,600 donors investing in our mission. Below are some examples of how your care made a difference:

- Purchased two Cell Savers, used in open-heart surgery and various other vascular procedures.
- Finalized renovations of Gerard Hall at Allen College, including the addition of a Collaboration Center for students and faculty.
- Upgraded exam lights at the Allen Women's Health Center.
- More than \$1,000,000 in Allen College student scholarships and awards distributed – the most ever!
- Facilitated transportation for patients to necessary appointments at the Black Hawk-Grundy Mental Health Center.
- Provided new bassinets for the Allen Hospital Birthing Center.
- Purchased new recliners for the Inpatient Rehab department.
- Ongoing funding to support our services at UnityPoint Hospice in Waterloo.
- New and updated ultrasound machines with guided IV access for three different areas at Allen Hospital.
- Further investment in the Simulation Program at Allen College.
- Professional development and educational opportunities for clinical and non-clinical staff.
- Support to help the growing list of patients and services at the Black Hawk-Grundy Mental Health Center.
- Acquired specialized equipment for the Sexual Assault Nurse Examiner (SANE) program in the Allen Hospital emergency department.
- Purchase of a vehicle for the K-9 program.
- Regular stocking of the "Heart Cart," which offers snacks and meals to team members during days with a high inpatient census.
- Granted many end-of-life wishes for hospice patients and their families
- And much more!

In addition to the many generous gifts from individuals and businesses, Allen Foundation's Grant Services team secured \$5.4 million from 38 local, state and federal grant programs during 2021. This funding supported Allen Hospital's Child Protection Center, Family Planning, and Maternal Health programs, as well as Allen College's ACE-SAP (Allen College Engagement & Salvation Army Partnership) Free Clinic, Summer Nurse & Health Careers Camp, and a program to recruit Psychiatric Mental Health Nurse Practitioner students.

The Black Hawk-Grundy Mental Health Center also benefitted from grant funding in support of the School-Based Mental Health Program used in the Waterloo and Cedar Falls Schools, a Transition from Homelessness program, and expanded Community Mental Health services. Other grants were garnered for a new Family Medicine Residency Program in partnership with UnityPoint Health – Des Moines, and a vaccine confidence program for COVID-19 and other infectious diseases.

The vast majority of these grant dollars – nearly 95% – come from state and federal grant sources and, therefore, are granted directly to the institution rather than to Allen Foundation. Even so, Allen Foundation's investment in these efforts generates widespread and positive returns across UnityPoint Health – Waterloo organizations and for the people and communities we serve.

Instead, students from the University of Northern Iowa's Alpha Phi Sorority hosted a series of virtual events to benefit cardiovascular services at Allen Hospital. Since 2018, the event has generated about \$35,000 for the hospital.

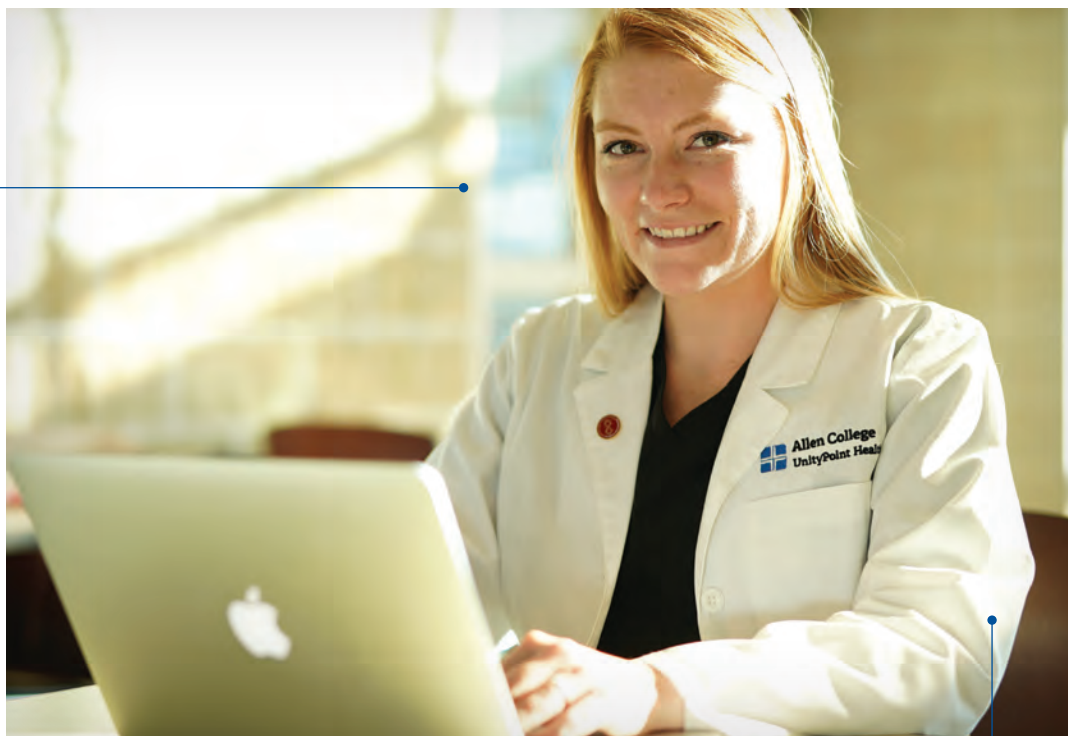
